By signing this Agreement, you agree to the following terms;

To return by or on the "Due Date" shown above, all materials described above via registered common carrier, insured for the equipment value indicated on the invoice: Global Marine Networks, LLC, 2668 Jericho Road, Maryville, TN 37803-2033. A \$500 deposit is required and will be refunded promptly on return of equipment and final air time invoicing (if applicable). The customer will be charged one week's rental for each week past the allocated grace period until the unit is returned without prior approval of rental extension by GMN.

To return equipment in the same condition as received, less reasonable wear and tear and agree to pay the equipment value amount (as indicated on the invoice) if the materials are not so returned.

To recognize that others are waiting to use the rented equipment and late returns will result in additional rental charges to you and inconvenience to other Global Marine Networks' (GMN) customers. A customer shall not receive a refund for equipment returned prior to the agreed rental contract end date.

It is understood and agreed upon by and between GMN and you, our customer, that rental equipment sent to you under this agreement shall be the responsibility of the customer him/herself, unless otherwise agreed upon and authorized by GMN.

To promptly contact GMN in the event that you experience any perceived technical difficulties with either the equipment or the service.

Items not returned will be charged at the normal retail value.

Per minute airtime whole minutes will be billed in accordance with the Iridium billing cycle (1st through 31st, i.e. January 1 through January 31 is a billing cycle). Please note that if your rental period includes time covered in two separate billing periods, you may see two separate airtime usage billings from GMN. Airtime used will be billed to the credit card number you have provided. Unless a pre-paid plan is selected, airtime charges are billed at \$1.85 per minute, to public switched telephone numbers and/or inbound calls made to the Iridium phone using the "Two-Stage Dialing Service"; \$0.99 per minute for Iridium-to-Iridium calls; \$9.99 per minute for Iridium-to-Other Satellite calls.

Portions of the equipment, including all documentation, manuals and packaging are copyrighted and contain proprietary information of Iridium. These materials may not be copied, photocopied, reproduced, translated or reduced to any electronic medium or machine readable form or otherwise duplicated or altered; in whole or in part, without the prior written consent of GMN and Iridium.

GMN makes no warranties with respect to the Iridium handset or other equipment used by you in connection with the Iridium service and expressly disclaims any and all expressed and implied warranties with respect thereto, including without limitation, any and all implied warranties of merchantability or fitness for a particular purpose. You accept the services on an "as is", "where is" basis. You acknowledge that Iridium does not warrant the availability, reliability, or any other aspect of the Iridium service. You hereby waive all warranties and conditions, express, implied or statutory, including any warranty of merchantable quality, fitness for a particular purpose, or availability or reliability, negligence, tort, statute, equity, contract, common law, or any other cause of action or legal or equitable theory. Under no circumstances will GMN be liable for any 1) interruptions or defects in the Iridium service which affect you for less than 48 continuous hours, or 2) indirect, aggravated, exemplary, punitive, special, incidental, or consequential damages (including damages for lost profits, lost revenues, lost information, business interruption, failure to realize anticipated savings or any other commercial or economic loss), or third party claims, expenses, costs, liability, loss or damage whatsoever, whether arising in negligence, tort, statute, equity, contract, common law, or any other cause of action or legal theory, even if GMN has been advised of the possibility of such damages. You agree, acknowledge and confirm that the limitations of liability set out in this Agreement are fair and reasonable in the commercial circumstances of this Agreement and that GMN would not have entered into this Agreement but for your agreement to limit GMN's liability in the manner, and to the extent provided herein.

By signing this agreement, the customer agrees to the terms and conditions set forth in the rental agreement and authorizes GMN to charge the credit card listed on page one for all fees, services, and shipping per the rental order form.
